HOW TO USE THE ALBERTA COVID RECORDS VERIFIER APP

Step 1: Download the app

With an internet connection, download the AB Covid Records Verifier app for free from Google Play or the App Store. Compatible tablets and mobile devices must run iOS 13 or Android 8 or higher.

You must allow the app to access your device camera.

Once you've downloaded the app, you can continue to use the app offline. No internet connection is required to scan QR codes.

Step 2: Scan Record

Patrons will either present:

A printed record with a QR code

Scanning tips

- Scanning from phone: Have patron turn up brightness on their phone and zoom into the QR code.
- Scanning from paper: Record might not scan if damaged, folded across the QR code, or if printed in small scale or low quality. Manually verify information on the printed portion of record, or ask patron to download new record from alberta.ca/CovidRecords
- Scanning multiple records: Click "scan next" before going to the next person.

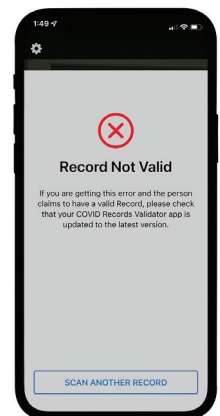
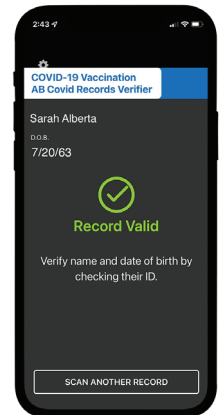
What you'll see after scanning

Record valid message

- Patrons' vaccine record meets all requirements. Move to Step 3-Check name and birthdate against their ID to verify identity.

Record not valid message

- The patron may not yet meet the vaccination requirements:
 - o full vaccination (14 days after second dose) is required after October 25
 - o partial vaccination (14 days after first dose) will be accepted until October 25
- If the patron feels there is a mistake, they can try downloading a new record from alberta.ca/CovidRecords.
- If a patron is not able to show proof of vaccination, a negative COVID-19 test (within the previous 24 hours) or medical exemption, they must be denied entry.



Step 3-Check against personal ID

After verifying proof of vaccination, you must check the identity of patrons 18 and older by ensuring the name and birthdate on their proof of vaccination record matches their personal ID to allow entry.

Businesses participating in the Restrictions Exemption Program must verify personal ID. Failure to comply could result in a \$2,000 fine or prosecution.

Examples of accepted personal identification include (photo ID not required):

- birth certificate
- citizenship card
- driver's licence
- government issued identification card
- health care card
- Métis card, Treaty card or Inuit status card
- passport



If the patrons' name or birthdate are incorrect, they must correct it using the steps listed on alberta.ca/CovidRecordsHelp
